This is to inform that 792 Prospective Rashtrapati Scout Application forms for the year 2018-19 of your State received vide above referred letters. Out of which 735 (Seven Hundred and Thirty Five) applications are found eligible for the Testing Camp after scrutiny at RHQ.

The reasons for Not Eligible are mentioned as under:-

4. Duration between Pratham Sopan & Dwitiya Sopan is not completed as per Syllabus. Form No. 261, 386, 544, 623, 698, 699, 720, 721, 722, 723, 760, 761, 762, 763, 764, 766, 779, 780, 783, 784, 788, 789, 792.
5. Duration between Dwitiya Sopan & Triliya Sopan is not completed as per Syllabus. Form No. 292, 609, 760, 761, 773, 792.
6. 14-B (4) – details of Proficiency Badges is not mentioned as per Syllabus. Form No. 206, 294, 499, 500, 569, 701.
7. 14-B (6) – details of Teaching Game is not completed as per Syllabus. Form No. 518.
8. 11 (10) – Prof. Badges for Dwitiya Sopan earned before completion of Pratham Sopan. Form No. 677.
