

| Who can participate | : Sr. Scouts, Sr. Guides, Rovers & Rangers between 15 to 25 Years of age, and who has completed Nipun Stage in Rover/Ranger section or Tiritiya Sopan in Scout/Guide section, having sound health may be selected according to the quota allotted to the State. Each candidate has to submit Physical Fitness Certificate from the appropriate authority. Unfit candidate should not be selected. |

| Fee | : Rs. 100/- Development Fee & Rs. 80/- Special Fee, Total Rs. 180/- per head for Sr. Scout/Guide/Rover/Ranger and Rs. 200/- Development Fee & Rs. 80/-Special Fee, Total Rs. 280/- per head for Ranger Leader to be paid at the time of Registration. |
| What to Carry | : 2 Sets of Correct & Complete Uniform as per APRO Part-II / III, Track Suit, Sleeping Bag. Warm bedding, Ruck sack. Comfortable Sport/Trekking Shoe, Sleeping mat, Plate and Mug, Spoon, Writing Material, Note Book, First-Aid Kit, Lunch Box, P-Cap, Warm Clothing, toilet requisites, Water-bottle, torch, P-Cap, Sun Glass, Talcum Powder, Antiseptic Cream, Personnel First-Aid Kit and other necessary material required for the Trekking camp. |
| Financial Assistance | : National Headquarters will reimburse second class (Sleeper) Concessional Train Fare and Actual Bus Fare (Ordinary/ Express Bus of State Transport authority only) on production of photocopy of Train Tickets and Bus Tickets in Original (No Taxi, Auto, AC/Volvo fare is admissible). Railway States should ensure utilization of Railway Pass. NOTE: The Travelling Expenses for the participants will be reimbursed to the State Association on receipt of Grant-in-Aid from the Govt. of India. Please inform the deputed candidates accordingly. The participants (Unit Leader) may please be instructed to submit their bank details along with T.E. Bill. |
| Risk Certificate | : Each candidate has to submit a Risk Certificate (Enclosed) duly signed by the Parents and attested by the District Commissioner. Application with Risk and Medical Certificate is to be handed over during 'Registration along with the deputation letter of the State. NOTE: Without Medical Fitness Certificate, Risk Certificate and deputation letter of the State, participants will not be admitted in the Camp. |
| Last Date of Application | : The name list of the selected candidates should reach to the Bharat Scouts and Guides, Western Regional Headquarters at adwr@bsgindia.org with a copy to State Secretary, BSG, Dadra & Nagar Haveli, U.T. at silvassascout@gmail.com on or before 15th October, 2017 along with the details of arrival and departure itinerary of the Participating Contingent. If your State is not utilizing the allotted quota, please inform at the earliest so that additional quota may be allotted to other States. |
